the TANGEDCO held on 30.10.2013 - Item No.16

Proceedings :

As per the existing provisions in the Tamil Nadu Electricity Board Service Regulations, the post of Assistant Engineer/ Electrical shall be filled in the ratio of 1:1 by Internal Selection and by Direct Recruitment. The qualification prescribed for the post of Assistant Engineer/ Electrical is B.E./ A.M.I.E with following discipline and the selection shall be made as per percentage of ratio as indicated against each, discipline :-

i)	Electrical and Electronics Engineering	-	91%
ii)	Electronics Communication Engineering	-	5%
iii)	Instrumentation Engineering	-	2%
iv)	Computer Science / Information Technology	-	2%

Nowadays the number of candidates from Instrumentation Engineering branch are less than Electronics and Communication Engineering completed candidates. Hence, the 2% ratio allotted to these candidates shall be merged with ECE candidates and allotment may be fixed for these both categories at 7%.

After careful consideration, TANGEDCO hereby directs that for various disciplines of B.E./B.Tech or equivalent qualifications or AMIE and Diploma in Electrical Engineering for appointment to the post of Assistant Engineer/ Electrical and Technical Assistant / Electrical respectively in future by Direct Recruitment

and by Internal Selection shall consist of persons possessing the prescribed qualification in the following percentage of ratio:-

i)	Electrical and Electronics Engineering	-	91%
ii)	Electronics Communication Engineering and Instrumentation Engineering	} -	7%
iii)	Computer Science / Information Technology	-	2%

Necessary amendments to the Tamil Nadu Electricity Board Service Regulations will be issued separately.


