Consequent to the issue of press release by the Chief Electoral Officer, Tamil Nadu, there is no restriction regarding publication of tender notices, processing of tenders and their finalization and issue of purchase orders. Therefore, there may not be any requirement for getting prior concurrence from the Election Commission of India regarding tenders. Similarly, from now onwards there is no restriction regarding promotions. Therefore, Preparation of panels, issue of promotion orders and consequential postings can proceed as usual. Similarly, transfer and posting can proceed as usual except in respect of officials connected with the conduct of elections. A copy of the press release is enclosed.

2. All the officers of TANGEDCO and TANTRANSCO are hereby instructed to comply with the above instructions immediately and to take follow up action.

The Election Commission of India has stated that in the State of Tamil Nadu where polling has been completed, the Commission has decided that all normal administrative work / development activities of the State may now be taken up, except in such districts where re-poll, if any, is pending. However, no officials connected with the conduct of elections can be transferred till the entire election process is completed and no review meetings can be held by the Ministers or any other political functionaries with the election related officials.
