**PROCEEDINGS:-**

In the Board's Proceedings first cited, orders were issued for payment of Remote Hydro/Cavern Allowance-cum-Performance Incentive to the employees working in Remote Hydro Stations.

2) Consequent on Revision of wages ordered with effect from 1-12-2007 and the Revision of Allowances/Special Pay, the Remote Hydro/Cavern Allowance-cum-Performance Incentive have been revised with effect from 1-9-2009 with the same conditions, laid down therein.

3) In the Board's Proceedings third cited orders were issued for payment of 100% Remote Hydro Allowance for the employees working in Remote Hydro Station/Kadamparai Power House.

4) The unions have demanded on the Wage Revision 2015 negotiation for grant of Remote Transmission Allowance to the employees working in Navamalai 230 KV SS and Vannathiparai 110 KV SS. Further the above substation was taken over by the Hydro wing and

the same to be included in category-III of the order in (Per) B.P. (FB) TANGEDCO Proceedings No.26, (SB) dated 06.08.2015 at 15% Remote Hydro Allowance.

5) The request has been examined in detail. After careful consideration, the TANGEDCO hereby order that the Officers and Staff working in Navamalai 230 KV SS and Vannathiparai 110 KV SS shall be eligible for grant of Remote Hydro Allowance @ 15% of Pay + Grade Pay and the said Sub Station shall be incorporated in Annexure to Category-III of (Per.) B.P (FB) No.26 (Secretariat Branch) dated : 06.08.2015.

6) This order shall take effect from 01.10.2017.

7) The expenditure sanctioned in para-5 above shall be debited to "TANGEDCO Funds – Revenue Expenses – 75.408 – Salaries – Other Allowances – Remote Hydro/Allowance.

8) The receipt of the Board's Proceedings shall be acknowledged.


